Textual Information()	<p>The promoter and promoter group shareholding of the Company as on June 30, 2017 shows a significant decrease as against the holding reported as on March 31, 2017. The difference in the promoter and promoter group shareholding during the quarter ended June 30, 2017 as against the position reported as on March 31, 2017 is due to the following transactions carried out during the quarter: (a) Mr. Suresh Deshpande, Promoter sold 1,31,467 equity shares in multiple tranches which was reported to the stock exchanges under the provisions of the SEBI (Prohibition of Insider Trading) Regulations, 2015 (b) Dr. Mukund Deshpande, Relative of a Promoter exercised 12,025 ESOPs during the quarter ended June 30, 2017 and sold 12,000 shares during the quarter. The required reporting of these transactions was made to the stock exchanges under the provisions of the SEBI (Prohibition of Insider Trading) Regulations, 2015 (c) Rama-Purushottam Foundation, Person Acting in Concert in the promoter group with effect from December 21, 2016, sold its entire shareholding i.e. 33,60,202 share during the quarter ended June 30, 2017 and the same was reported to the stock exchanges under the provisions of the SEBI (Prohibition of Insider Trading) Regulations, 2015 Therefore, the shareholding of the promoter group has changes and the revised position as on June 30, 2017 is as follows: Q4FY17 No. of members in Promoter and Promoter Group = 9; Aggregate No. of shares held by Promoter and Promoter Group = 2,80,19,173 Q1FY18 No. of members in Promoter and Promoter Group = 8; Aggregate No. of shares held by Promoter and Promoter Group = 2,45,27,429 [i.e. Net reduction of 1 (One) member from Promoter Group and 34,91,744 No. of Shares]</p>
