Brief profile	Mr. Lewin is the President and Chief Executive Officer of the Computer History Museum (CHM), a nonprofit organization with a four-decade history exploring the world's computing past, digital present, and future impact of technology on humanity. Lewin directs the strategic planning, fundraising, and ongoing operations of CHM.
		Prior to CHM, Lewin led Microsoft's work in applying technology for public good during a 17-year tenure. He collaborated cross-company and with external partners to focus on scalable impact, with a portfolio that includes establishing the company's global startup and venture capital engagement model, its campaign and civic tech engagement efforts, affordable internet access initiatives, environmental sustainability work, and partnerships with leading research universities.
		Prior to Microsoft Lewin accrued 30-plus years of leadership experience in Silicon Valley. He led the initial launch of the Macintosh to higher education for Apple Computer, Inc, as a founder of NeXT, Inc, and led sales and marketing for GO Corporation. Lewin also served as CEO of Aurigin Systems, Inc., a company that pioneered the market for Intellectual Property Asset Management, bringing investors, corporate, academic, and civic leaders together to advance emerging technology, digital transformation, and sustainability initiatives. Lewin has helped organizations build long-term competitive positioning,
